PRE-QUALIFICATION FOR PROVISION AND OPERATION OF MODULAR GAS PROCESSING UNIT (“CAPACITY EXPANSION WORKS”) ON A PERFORMANCE BASED CONTRACT MODEL AT HMGPP : DIROK FIELD – ASSAM: BLOCK: AAP-ON-94/1

Hindustan Oil Exploration Company Ltd. (“HOEC”) is the Operator of the AAP-ON-94/1 Block located near Margherita, Tinsukia District, Assam, India. Oil India Ltd and Indian Oil Corporation Ltd are its other joint venture partners.

HOEC has established the Hollong Modular Gas Processing Plant (HMGPP) in Agbandha Village in Margherita . The plant is currently handling 1 MMSCMD gas and about 850 bbls of condensate.

HOEC along with the its joint venture partners is in the process of further development of the block to realize the full potential. In view of the proposed further development, HOEC is considering enhancing the existing processing capacity of HMGPP by another 1 MMSCMD of gas and additional condensate handling facilities with modular units on a performance-based contract model.

Operator seeks an Expression of Interest under International Competitive Bidding (“ICB”) process from experienced Contractors for provision and operation Modular Gas Processing Unit (“Capacity Expansion Works”) at H MGPP , Augbandha village, Marghereta , on a performance based contract model. Brief description of the requirement is given below:

Work Scope

The existing plant is designed and installed with modular units to handle 1 MMSCMD of sweet gas, 850 barrels per day of condensate and 1000 barrels per day of produced water and the plant is operated by a contractor on Performance based contract model.

New facilities are required now to meet the revised total capacity of 2 MMSCMD of sweet gas, 1500 barrels per day of condensate and 1000 barrels per day of produced water. The existing plant has no water dew pointing facility, hence the new facility should have modules to water dewpoint to 0 deg c at export pressure for total 2 MMSCMD gas. The arrival pressure of fluids at inlet of the plant is around 25 barg and gas export pressure is around 20barg. Existing power plant has enough electrical power to support the additional facilities. Civil foundation works will be done by HOEC based on the design provided by the contractor.

Contract Duration

HOEC is contemplating for commencement of the expanded unit during CY 2020 to suit the overall Field development objective. The Firm Contract duration could be 15 years with 5 years extension option and with further options to buy back the modules.

Detailed Scope of Work

Detailed scope of work will be given in the Tender Documents which will be issued to the prequalified contractors.

Shortlisting of bidders for issue of Tender Documents

Considering the criticality and complexity of the requirement, bidders/ consortium of bidders who meet the following minimum experience and financial capability shall only be shortlisted for issue of Tender Documents.

Past Experience

Minimum five (5) years of demonstrable experience in provision and operation of modular gas processing units on a performance based contract model. If required, HOEC representative will have to be provided access to visit such facility where the bidder has carried out or operating such works.

Financial Capability

Bidder should meet following financial criteria:

- Annual Turnover: Average annual Turnover of the past 3 years should not be less than USD 15 million.
- Positive Net worth with at least USD 10 million in the past preceding three financial years
- Company should have demonstrable working capital to meet its project obligation.

Bidder to Submit following documents:

- Details of Organization, HSE Organization with responsibilities, resources owned and at disposal, Quality Standards and documentation practices, Risk management, Planning and performance monitoring practices.
- Organizational outline proposal detailing their nominated management and staff and brief execution plan to provide such works on turnkey basis.
- Details of jobs currently under execution and likely date of completion.
- Technical Job Capability. List of Similar work with contract values successfully executed in the last 5 years and projects currently under execution
- A demonstrable capability to mobilize and commence work to meet HOEC schedule. The Contractor's experience in mobilizing on schedule shall be clearly stated.
- Audited financial statements for the last three years.
- Details of latest technology (if any) applied by the Contractor around company's operational area
- Reference of two or three major clients that can be contacted for information and reference for similar work.

Interested bidders/ Consortium of bidders who can fulfill all of the specifics listed above must submit their responses within 14 working days from the day of publication of this advertisement. All responses should be sent, in a sealed envelope superscripting the respective supply/service for which the interest is being expressed. Responding to the EOI
